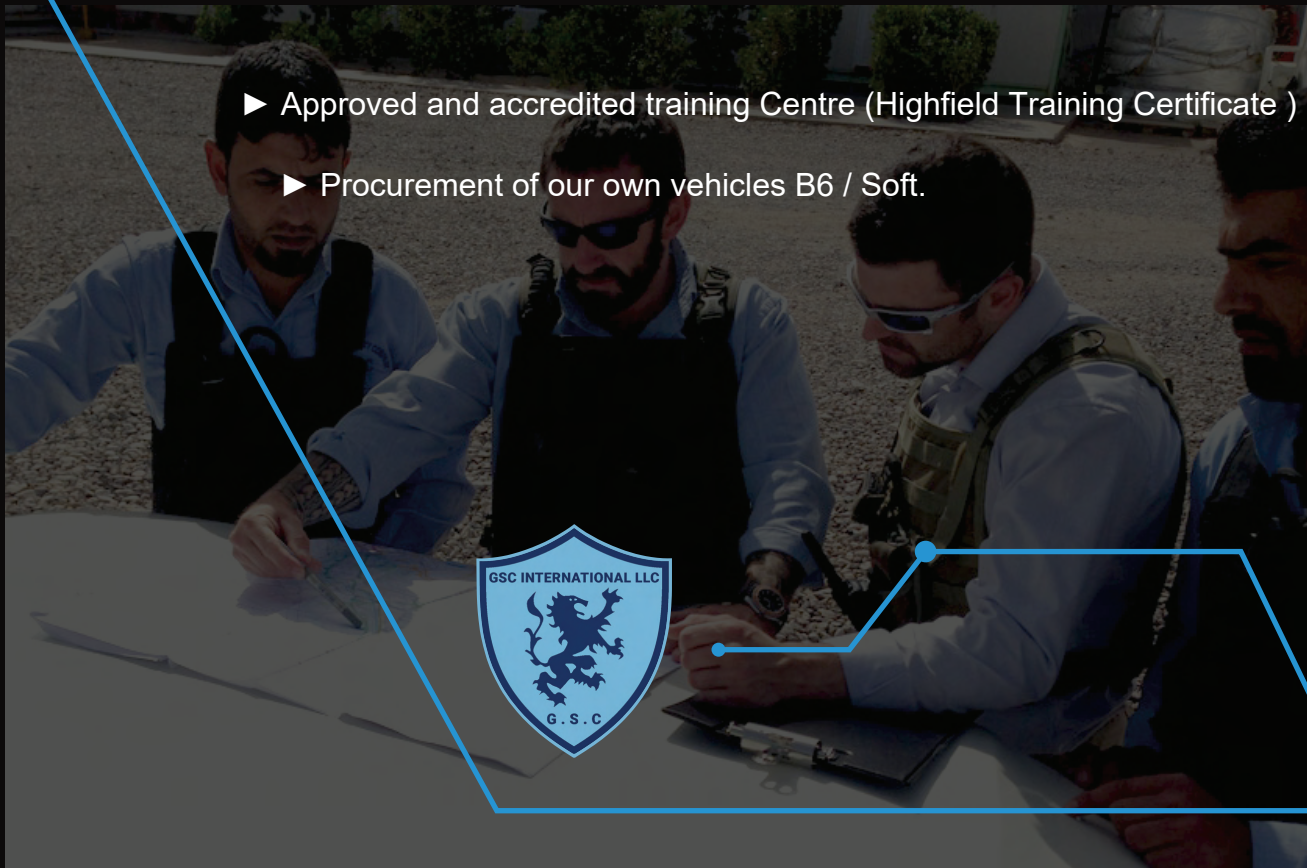

| Added Value

- ▶ Standing fleet of 50 B6 Armoured vehicles, including ambulances, coaches, minibuses and pickups. The majority are new model Toyota.

| Mobile

GSC International has extensive expertise in supplying specialized mobile security teams for both ongoing and ad hoc projects. We run a fleet of armored B6 SUVs and soft-skinned 4x4s to meet the needs of our customers for safe transportation in a variety of settings.

Through a complex network of physical communication channels, our operations center oversees the travel of all mobile security teams and responds to incidents. We keep a close eye on our fleet with the help of VHF radio, satellite, and GSM capabilities installed in each vehicle and available as portable tracking systems.

| Training

GSC International has allotted enough money to ensure that each employee receives the training they require to perform their tasks successfully, both at the company headquarters and on client assignments.

Training and development, in the opinion of GSC International, is well worth the time and money it takes to implement because of the positive effects it has on the firm as a whole and on the individual employees who undergo it . At the same time as boosting employee morale and elevating the firm's image among consumers.

We may provide credentials that are fully authorized, meaning they have been sanctioned by the relevant regulatory bodies in the UK and are therefore accepted internationally. Iraq 's Ministry of Interior has given GSC International permission to hold security training courses through the country's High field recognized training system.

| The Tools

As part of the standard operating procedure followed by the company when deploying workers, each employee at GSC International is issued a personal protective equipment (PPE) kit in addition to a digitally secure and fundamentally safe handheld radio. This is done as part of the company's routine procedure for deploying workers.

Communications

There are two channels of contact available to all on-duty GSC International employees at all times. Any and all cars are equipped with a state-of-the-art communication system that can do anything from -

- ▶ Transmittal of messages between vehicles and the GSC International Operations cell from all necessary places in a timely fashion
- ▶ Use at intrinsically safe areas, including DG 1, 2, and 3 sites and oil and gas Class 1, 2, and 3 locations
- ▶ Protects against eavesdropping
- ▶ Capacity for use with cellular phones
- ▶ Access to electronic mail and SMS messaging
- ▶ Mobile base stations that can provide service in even the most inaccessible areas
- ▶ The capacity for location-based monitoring (Global Positioning System/ In Vehicle Management System).
- ▶ Indicator Button for Imminent Danger
- ▶ All of the radios in our organization, whether they be handheld or installed in vehicles, are digital and up-to-date..
- ▶ Each car has a satellite phone in case of emergency.
- ▶ We use an IVMS system (in-vehicle monitoring system) that is controlled by our operations room and is available to our clients based on their individual levels of urgency.

Innovative Solution

GSC International is structured to provide clients with an innovative, flexible and cost-efficient security force, equipped and manned to protect and support the full spectrum of customer operations, Iraq-wide. In consultation with the Clients, GSC International management will task organise assets to create a bespoke solution to meet the business needs of that day. This will open up the information chain down to operators and up to the project management in a timely fashion. GSC International have ability to expand the project where necessary and swiftly.

Ambulance Services

Our company provides service of providing B6 / Soft Ambulance inclusive of its medical equipment which is compliant with BP/Shell standards. We can provide Expat/Local qualified medics based on our clients required standards.

Treatment and Care

All medical equipment used in support of ROO / IDC operations will be compliant thanks to GSC International 's diligence. This pertains to the GSC International Primary Care package as well. The medical staff at the GSC International is qualified and equipped to handle the following situations:

- ▶ Wounds from gunfire
- ▶ Explosion and severe burns
- ▶ Fractures
- ▶ Injury from oil and gas work, car accidents, and other violent events

All staff members at the GSC International have at least Medic First Aid and Basic Life Saver certification.

It is mandatory for all senior members of the LN and international personnel to receive training in MFA Advanced Life Saver as well as other security measures for contractors , as described in the ROO Contractors Medical Minimum Standards document.

Each GSC International IDC team will carry an AED (automated external defibrillator) and an ECG (electrocardiogram) monitor , and all client - carrying cars used by GSC International come equipped as standard with a first -aid box and a trauma kit. In addition , GSC International Teams are outfitted with oxygen delivery equipment from EmOx.

In the event of a crisis , the B6 armored vehicles are capable of being modified to make room for essential medical supplies and equipment like stretchers.

| K-9 Assistance

GSC International dogs are the only ones in Iraq that receive specialized training in searching buildings and vehicles, tracking items, protecting handlers, and locating missing people.

When it comes to explosives, our canines receive specialist training on certain compounds that define the precise make-up of explosives. Detection canines used by our Iraqi canine service receive regular training to ensure they deliver top-notch results with minimal disruption to the general public and potential customers.

| Weapons & Storage

GSC International weapons and ammunition are subject to MoI regulations. No GSC International employee holds any personal weapon that is not registered to the company. GSC International weapons and ammunition are:

- ▶ Held in a secure and dedicated armoury with an audible alarm system.
- ▶ Allocated to each individual employee with weapon card.
- ▶ Trained with regularly and each employee has passed mandatory weapons tests and range periods with the GSC International allocated weapon.
- ▶ Available for regular inspection.
- ▶ Weapons will be maintained to the highest possible standard and regularly checked by a qualified armourer. All weapons systems will be compliant with all applicable Iraqi law and will be licensed with weapon cards.
- ▶ All loading and unloading will be carried out in established bays.
- ▶ Ammunition is from a standardised source and not modified in any way.
- ▶ The ammunition is marked and stamped to show age and quality.

| HSE Policy
